He then proceeded to Carson City three short months later and broke his promise by voting for SB475, a \$600 million-plus tax hike!

Oscarson then ran for re-election in 2014...and again promised he wouldn't raise taxes.

According to the Moapa Valley Progress newspaper, AD36 constituent Tina Trenner said that "Oscarson had spoken to Pahrump Republicans and promised that he would not vote for the new tax."

Trenner was referring to the proposed margins tax that was on the 2014 ballot that 85% of voters in the district voted against.

"He told us not to worry, that he would never vote for it," Trenner said.

But Oscarson again went back to Carson City and AGAIN broke his word.

Worse, he was reportedly the deciding vote that approved the largest tax hike in Nevada history!

Republicans in the Assembly who were opposed to Gov. Brian Sandoval's



Reno Gazette-Journal he was "within a vote" of getting the 15 he needed.

"Right after saying that," the paper reported, "Assemblyman James Oscarson, R-Pharump, announced he was supporting Sandoval's tax plan."

The Nevada Policy Research Institute confirmed the betrayal in a post-session wrap-up...

"Assembly members had been unified against implementing a gross receipts tax for three and a half months, but the governor soon got (Speaker John) Hambrick and (Majority Leader Paul) Anderson to buckle and support his new tax increase. Then word got out that Assemblyman James Oscarson, a Republican from Pahrump — one of the most conservative districts in Nevada — was going back on assurances he'd made to constituents and would now support the governor's tax plan."

Worse, Oscarson voted for a total of 29 out of 32 tax/fee hikes during the same session!

- 27. Senate Bill 489 Imposed an license tax on "peer support recovery organizations"
- 28. Senate Bill 498 Created a tax on community health workers
- 29. Senate Bill 502 Increased taxes paid to the DMV on all transactions

Which brings to mind what Grover Norquist, president of Americans for Tax Reform, says about "rathead" Republicans who vote for tax hikes...

"Raising taxes is a sign of incompetence in a politician. He/she cannot manage. A willingness to raise taxes is telegraphing such failure."

So true. A true failure. But when push came to shove, Oscarson buckled under pressure and fell in line with Sandoval and the governor's bogus claim that more money was needed for education.

Trenner, who ended up challenging Oscarson in the June GOP primary, didn't buy the manure Oscarson was shoveling...

"Governor Kenny Guin raised taxes (in 2003), with the highest increase the state had ever seen. It was all for education and our children. But all these years later we are still number 50 in education. If we throw more money, can we get any worse? How do you get worse than #50? Money was not the answer then and it is not the answer now."

A second primary challenger, Rusty Stanberry, was having none of it either...

"Our current incumbent

Assemblyman James Oscarson has not acted on the conservative Republican values in which he was elected and has failed our District. He was part of the largest tax increase, after promising the voters he would not raise taxes. Oscarson is part of the problem, not the solution for Nevada."

But this was nothing compared to the fury felt by the leaders and members of the Nye County Republican Party which "spent their time, effort, energy and money to help get...Oscarson reelected."

In fact, they EXCOMMUNICATED him!

In a scathing resolution passed unanimously, the party's Central Committee declared that...

"Assemblyman James Oscarson came before the Nye County Central Committee and promised not to vote for any new taxes" and then "DEFRAUDING Republicans and violating Republican Principles & Platforms" by voting for "the largest tax increase in Nevada history."

As such, the party declared that due to his "betrayal of the trust and responsibility to Republicans," Oscarson made himself "unwelcome to enjoy the privilege of being honorary members of the Nye County Republican Central Committee.

The resolution further resolved that...

"Assemblyman James Oscarson no longer (has) the support of the Nye County Republican Central Committee" and " the Nye County Republican Central Committee encourages Republicans in Nye County and throughout Nevada to withhold any future support from James Oscarson in any future elections."

OUCH!

In addition, former Assemblyman Goedhart – whose seat Oscarson took in 2012 – is supporting Oscarson's independent opponent in the 2016 general election.

"Since I served three terms as your assemblyman for District 36," Goedhart wrote in a post-primary email, "I know what it takes to do the job.

Dennis Hof is the right choice. I endorse Dennis for our next assemblyman for District 36." I'm guessing he won't be alone.
